A. INTRODUCTION

- 1. In this proceeding, the ACCC alleges that during the period between at least 1 January 2019 to 10 February 2022 (the **Relevant Period**), the Respondent (**Meg's Flowers**), which is an online floristry business, made false or misleading representations and engaged in misleading or deceptive conduct by representations published on its websites and in Google advertisements which represented that Meg's Flowers was a local florist, located in a specific town, suburb or locality in Australia when that was not the case. In fact, orders placed with Meg's Flowers were fulfilled from any one of 13 warehouses used by Meg's Flowers, or, in some instances, by sub-contractors.
- 2. By making these representations, Meg's Flowers contravened ss 18, 29 and 33 of the Australian Consumer Law (**ACL**), being Schedule 2 to the *Competition and Consumer Act* 2010 (Cth).

B. IMPORTANT FACTS GIVING RISE TO THE CLAIM

- 3. Meg's Flowers operated a predominantly warehouse-based flower delivery service. It did not directly maintain any local shopfront accessible to customers. It received flower orders by telephone, or through a large number of websites. Meg's Flowers used Google advertisements to promote its websites to consumers.
- 4. It was Meg's Flowers' business practice to generate town, suburb or locality-specific websites, which incorporated elements (including at least the domain name element, the first location heading element and the local copyright element) referring to a specific town, suburb or locality for locations in which it had no physical presence.
- 5. During the Relevant Period, Meg's Flowers made statements on seven location-specific websites (the **named websites**), referring to Ashgrove, Queensland; Caboolture, Queensland; Ellenbrook, Western Australia; Lane Cove, New South Wales; Mawson

Each of these named websites included a combination of at least five of the following elements:

- a. a reference to the relevant town, suburb or locality name in the domain name (the domain name element);
- b. the name of the relevant town, suburb or locality and a phone number with the area code of the state or territory the town, suburb or locality is located in at the top of the page (first location heading element);
- c. a photograph of a florist's store with a scooter branded Meg's Flowers (photograph element);
- d. the heading, "[relevant town, suburb or locality] Florist" (second location heading element);
- e. geographical details about the relevant town, suburb or locality (location description element);
- f. the statement, "direct from [...] our [relevant town, suburb or locality] florist" (location delivery element);
- g. the statement "the finest quality flowers in [relevant town, suburb or locality]" (location of flowers element);
- h. the statement "It's a local approach" (local approach element);
- i. the statement "our fantastic local service" (local service element); and
- j. the copyright notice "© [Year] Meg's Flowers [relevant town, suburb or locality name]" (local copyright element).
- 6. **Annexure A** shows the Meg's Flowers named website for Ashgrove, Queensland as it appeared during the Relevant Period. This website included all ten of the elements set out in paragraph 5.
- 7. **Annexure B** sets out, for each named website, the relevant suburb, URL and period alleged, and indicates which of the elements set out in paragraph 5 was included on the named website. By including a combination of some of the elements set out in paragraph 5 on each named website, Meg's Flowers represented that flowers ordered from Meg's Flowers originated from a florist located in the town, suburb or locality referred to in the website (the **website local origin representation**), when this was not the case.
- 8. Meg's Flowers also published 149 other town, suburb or locality specific websites (other websites). During the Relevant Period, each of the other websites included at least the following elements:
 - a. the domain name element;
 - b. the first location heading element;
 - c. the local copyright element; and

- d. the location description element.
- 9. By including each of the elements referred to in paragraph 8 on each of the Meg's Flowers other websites, Meg's Flowers made the website local origin representation.

Google Advertisements

- 10. During at least the Relevant Period, Meg's Flowers also used the Google advertising platform. Meg's Flowers provided information to the platform and the platform generated advertisements that were displayed as search listings.
- 11. Where a user of the Google search engine searched for "[relevant town, suburb or locality] Florist" or "Florist in [relevant town, suburb or locality]" or "Florists in [relevant town, suburb or locality]" or "flower delivery [relevant town, suburb or locality]" or "flowers in [relevant town, suburb or locality]", the search results generated included a sponsored Meg's Flowers advertisement referring to the relevant town, suburb or locality.
- 12. During the Relevant Period, Meg's Flowers caused 7,462 advertisements to be published for websites relating to 3,649 suburbs, towns or localities (**Meg's Flowers advertisements**), that displayed each of the following elements, supplied and approved by Meg's Flowers:
 - a. a website domain name (**linked local website**), which referred to the town, suburb or locality;
 - b. a headline, which was in the form "Meg's Florist [relevant town, suburb or locality]" or "Meg's [relevant town, suburb or locality]"; and
 - c. a reference to "Same Day Local Flower Delivery".
- 13. By including each of the the elements referred to in paragraph 12 in the advertisements, Meg's Flowers represented that flowers ordered from Meg's Flowers originated from a florist located in the town, suburb or locality referred to in the advertisement (ad local origin representation), when this was not the case.
- 14. Below is an example of a Meg's Flowers advertisement for the Meg's Flowers Ashgrove website:

Meg's Florist Ashgrove I Call us M-F 7am-8pm. Sat 7-4pm I Same Day Local Flower Delivery megsflowersashgrove.com.au/qld/brisbane Daily Deliveries of stunning flowers Mon-Sat. Call Us or O rder on our Website. Divine and affordable flowers and gifts by passionate florists. Same Day Delivery Mon-Sat.

15. The website local origin representations and ad local origin representations were false, misleading, deceptive or likely to mislead or deceive, because the flowers that were ordered from Meg's Flowers did not originate from a florist located in the town, suburb or locality referred to in the website or advertisement in which the representations were made.

C. SUMMARY OF RELIEF SOUGHT FROM THE COURT

16. The Applicant claims the relief set out in the accompanying Originating Application, which includes declarations, pecuniary penalties, compliance orders, corrective notices, and costs.

D. PRIMARY LEGAL GROUNDS FOR RELIEF SOUGHT

- 17. The conduct alleged above was in trade or commerce and in connection with the supply or possible supply of goods or services or in connection with the promotion by any means of the supply or use of goods or services.
- 18. By reason of the matters described at paragraphs 3 to 15 above, Meg's Flowers:
 - a. engaged in conduct that was misleading or deceptive, or likely to mislead or deceive, in contravention of s 18 of the ACL;
 - b. made false or misleading representation concerning the place of origin of goods in contravention of s 29(1)(k) of the ACL; and
 - c. engaged in conduct that was liable to mislead the public as to the nature or characteristics of goods, in contravention of s 33 of the ACL.

E. ALLEGED HARM

19. The origin representations may have resulted in consumers who sought to shop locally and support a local business purchasing from Meg's Flowers instead of purchasing flowers from a local florist.

F. OTHER

20. The Applicant does not consider the issues in this Concise Statement are suitable for a report by a referee under s 54A of the *Federal Court of Australia Act 1976*.
